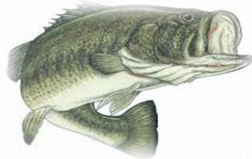




## **4th Annual Bass Team Tournament**

**SATURDAY, APRIL 4, 2020**  
**Safe light to 3:00 PM**  
**GREERS FERRY LAKE, DEVILS FORK**

First Place: Guaranteed \$1000 / Pays for every 10 boats  
\$110 per Boat Includes BIG BASS (2 fisherman per boat) (for early entries)  
**\$125 entry fee day of tournament**  
Check-in from 4:30-5:30 am at Devil's Fork Pavilion / Take-Off 6 am or First Light  
Paid registration determines boat order  
Weigh in at Devils Fork Pavilion 3:00pm  
Lots of Prizes, Lunch provided  
**Pre-Registration is encouraged**



### **SHOP WITH A COP BASS TOURNAMENT RULES**

1. All fishermen must have a valid Arkansas fishing license.
2. No Alcohol or illegal drugs at any time.
3. Tournament limit is five (5) bass.
4. If you present more than five (5) bass for weigh-in, officials will cull your sack down, starting with the largest fish.
5. Kentucky Spotted Bass and Smallmouth must measure a minimum of 12 inches. Largemouth must measure at least 15 inches. Officials will make effort to make your fish measure on a flat board with mouth closed.
6. Mutilated or otherwise altered fish will not be weighed.
7. Live release, Penalty for dead fish will be a half (½) pound.
8. Late penalty is one (1) pound per minute late. After 10 minutes you will be disqualified.
9. Live wells will be checked prior to take off with a ribbon placed on your boat.
10. Life jackets must be worn anytime the gas motor is running.
11. Kill switch must be operable and attached to the driver.
12. No live bait.
13. No trolling with the gas motor.
14. No fishing within 50 yards of a gas dock.
15. You may not leave the boat to make a cast or land a fish. All fishing must be done from a boat.
16. The use of any personal communication device during tournament hours to increase your catch potential is prohibited.
17. No non-participants allowed in your boat during tournament fishing hours unless you are helping someone in distress.
18. Winners may be required to submit to a polygraph test.
